## **Rules and Regulations:**

This is not a juried event, but there is an expectation all work must be designed and executed by the exhibitor. No imported or buy/sell goods will be eligible to be exhibited. Stuffed animals or dolls must be handmade, not decorated, commercially made products. Work made from kits of any kind is unacceptable. Your work may incorporate such commercially produced parts such as jewelry findings, or plastic flowers, but only to a small degree.

Food vendors <u>must</u> submit a menu, copies of required permits and Certificates of Insurance.

#### For ALL Vendors:

Set-up time permitted from 8-9:30 am on Saturday. Once you have unloaded your vehicle, please park it in town. You will be expected to stay until breakdown time at 4 pm.

NO vehicles will be allowed in the exhibit area during show hours.

Exhibitors must provide their own display equipment set-up. There is no electricity on site and generators are NOT permitted for arts and crafts vendors. The exhibit space will be in an area filled with gravel. Please don't plan on using stakes. It is recommended to have a waterproof cover with weights at each corner. Please be prepared for an outdoor site. You will be assigned a space number.

Arts/craft spaces measure 10'x10. Infringement will not be tolerated on neighboring spaces. Please keep all your packing material and extra merchandise inside your area, tent or your vehicle.

Vendors are responsible for the removal of their own garbage, including any and all zip ties. Please help keep our town litter free.

No refunds after acceptance to the show, or if we have to cancel due to "Acts of God," i.e. extreme weather, etc. We will do our best to arrange wonderful weather for the show, and if for some reason we have to cancel you will be notified by email the week of the show.

We will continue to accept applications on a first come first serve basis up until the show date, if spaces are available.
